We the Subscribers being Chosen a Committee to view the Road from  
 Cap: Daniel Hardy to Rowley Road by Rowton and also a Road  
 petitioned for by Deion William Hardy to Rowley Road aforesaid  
 and having viewed the Road are of opinion that the De  
 by Deion Hardy is most beneficial to the publick and Left  
 to y<sup>e</sup> private and it being much less trouble to erect as follow  
 viz that the Road begin at the afore said Rowley Road  
 lead from Rowton so Run on y<sup>e</sup> East Side of Abraham Parkers  
 Land y<sup>e</sup> he bought of Baley till it come to a maple tree  
 Littel bridge at y<sup>e</sup> head of Hardy's pasture then turning a littel  
 the East so there Lying on y<sup>e</sup> West Side of Hardy's farm to  
 Come to y<sup>e</sup> first way by Merrimack River - Except against  
 hill by Samuel Hardy's then to turn unto Deion's Land  
 & pass y<sup>e</sup> hill and to turn unto Hardy's Land as soon  
 be with conveniency and so to go to y<sup>e</sup> afore said way by  
 provided y<sup>e</sup> petitioners make y<sup>e</sup> way good and sealable to y<sup>e</sup>  
 of a Committee of maybe Chosen to view the same and all  
 the Charge of a Committee upon there receiving the money  
 for them Daniel Hardy

Bradford December 22 1742 we the Subscribers being met together  
 and at y<sup>e</sup> Desire of several of y<sup>e</sup> Subscribers of our Town have  
 Request made to us have proceeded and Layed out a town Road  
 following to begin at Rowley Road y<sup>e</sup> Lead to Rowton at a  
 which pine tree marked Standing about west from James Hardy's  
 and being on Land of Lieut Abraham Parkers one Rod and an  
 wide to y<sup>e</sup> west of a pine Running Northwardly to a littel  
 oak tree marked so on to a black oak tree marked  
 on y<sup>e</sup> Edge of a littel hill then to a littel pitch pine tree mark  
 on to a Stake and Stone Standing in Hardy's Line of Road  
 to y<sup>e</sup> west of all y<sup>e</sup> above marked bounds so running along  
 line toward Merrimack River till it Come to a maple tree  
 y<sup>e</sup> bound between Deion Parkers and Hardy's Land and then to  
 Hardy's Land till it Come near a against Samuel Hardy's Land  
 in on Deion's Land round y<sup>e</sup> End of y<sup>e</sup> hill till it Come  
 Hardy's Land again and so on Hardy's Land to y<sup>e</sup> Country  
 Come out to be the Road this Road is to be one
