To tach Carof the poor for titheing men were Chosen David Kimball

At a Legall Town meeting of the Inhabitants of the Town of Bradford  
may th<sup>e</sup> 15 – 1717 then were Chosen Ser John Boynton moderater for the  
presente meeting voted and passed one the afermitive that it is the mind  
of the town to Comply with a motion made by Sundry Gentelmen of newbery to  
profer a pitision to the General Court that theremay be a Division of the County  
of Essex and to Desire and Empower the Select men of our town to sign a A  
pitision to the General Court Refering to that affair so with the Select men  
or other Gentlemen of the Neighboaring Town that are or may be Chosen to  
act in that affair

At a Legall Town meeting of the Inhabitance of the town of  
Bradford September the 16 : 1717 Deacen Samuel Tenne Moderater

then was voted and passed one thae Afermitive that the present Select men  
Should provide the town with a Schoolmaster to tech School till the Last  
of march which will be 1718
